The Ground Plott of ffirst Story

The Greate Capitall messuage Called the Postmaistres howse alias ffoxes Courte, and one messuage or Tenement on the north syde of the passage in the Tenure of Daniell Hall, all which lye on the west syd of St. Nicholas Lane in the parish of St. Nicholas Accion and diverse Tenements and one Alley behind the same in Abchurch Lane in the parish of St. Mary Abchurch, all which aforesayed are demysed and in the Tenure of Mr. Parler by Lease, St. Nicholas Lane aforesayed against the East, The Company of Grocers in the Tenure of Doctor Hone and this Company of Clothworkers against the North Abchurch Lane and the Tenements aforesayed belonging to this Company against the west, The Lane belonging to the Parish of St. Augustins at Paules gate, and Edmund Pretty in the right of his wife against the South, as more plainely appeareth by this Plott ffollowing,

A Chamber ouer the kitchen and Hall with a clossett in it, which Chamber conteyneth in Length with the Chimney 29 foote $\frac{1}{2}$, and in bredth at the west end 24 foote $\frac{1}{4}$, and at the East end 21 foote $\frac{1}{4}$ One other Chamber adioyning to the same being ouer parte of the Parlor with a Chimney in it Cont, in Length 25 foote, and bredth 14 foote $\frac{1}{2}$, A staircase with a howse of office on the north syd, conteining in Length 11 foote $\frac{1}{2}$, and in bredth 8 foote, One chamber with a Chimney ouer parte of Daniell Halls warehowse, A Chamber ouer the gate at the East end of the Courte aforesayed Cont: in length 20 foote $\frac{1}{2}$ and in bredth besydes the two litle Clossetts 14 foote $\frac{1}{2}$, One other Chamber adioyning Cont: in Length 20 foote $\frac{1}{2}$ and in bredth 15 foote $\frac{1}{2}$, Also a gallery leading vnto the same two Chambers conteyning in Length 44 foote, and in bredth 4 foote with a howse of office at the south end, A Chamber with a Chimney which Chamber is on the south syd of the Courte and Cont: in Length 24 foote and in bredth 19 foote $\frac{1}{4}$, A Gallery on the same syd cont: in length 21 foote, and in bredth 4 foote 9 inches. One other chamber conteining in Length 20 foote, and in bredth 12 foote $\frac{1}{2}$, Also one litle Studdy adioyning being in the stairecase, One other roome ouer a warehowse cont: in Length 25 foote $\frac{1}{4}$, and in bredth 19 foote $\frac{1}{2}$, One other roome hanging parte ouer the yard or Courte being at the west end of the sayed Courte conteyning in Length with the staires and passage 17 foote, and in bredth 13 foote $\frac{1}{2}$, A Chamber next Abchurch Lane being ouer ffawcetts shope conteyning in Length 23 foote and in bredth 11 foote $\frac{1}{2}$, A Chamber ouer Mr Extons kitchen conteining in length 21 foote $\frac{1}{2}$ and in bredth 16 foote $\frac{1}{2}$

A Chamber with a Chimney and Clossett conteyning in Length 26 foote $\frac{1}{2}$, and in bredth 15 foote 9 inches, One other litle Chamber cont: in Length with the entry and passage 15 foote $\frac{1}{2}$, and in bredth 14 foote $\frac{1}{2}$, One other Chamber conteyning 15 foote longe, and 11 foote $\frac{1}{2}$ broade, One other Chamber adioyning with a Chimney in it, The Stairecase with the howse of office cont: in Length 11 foote, and in bredth 9 foote, A Chamber ouer the gate Cont: in length 23 foote $\frac{1}{2}$ and in bredth with the Chimney 14 foote $\frac{1}{2}$, One other Chamber on the south syd the same conteyning in length 23 foote $\frac{1}{2}$, and in bredth with the Chimney 14 foote $\frac{1}{2}$, One other Chamber cont: in Length 23 foote $\frac{1}{2}$ and in bredth 14 foote $\frac{1}{2}$, One Longe Gallery serving for the three Chambers aforesayed conteyning in Length 44 foote, and in bredth 3 foote, A litle Chamber at the west end of the Courte Cont: in Length 14 foote and in bredth 13 foote, One other Chamber Cont: in Length 21 foote $\frac{1}{2}$, and in bredth with the Chimney 15 foote $\frac{1}{2}$.

A Chamber on the north syd the Courte Cont: in Length 15 foote $\frac{1}{2}$, One other Chamber adioyning to the same being next the Courte Cont: in Length with the Chimney and Clossett 17 foote $\frac{1}{2}$, & in bredth 12 foote $\frac{1}{2}$ Two other Chambers adioyning one with a Chimney Cont; in Length 29 foote, and in bredth 20 foote, A Chamber adioyning Cont: in Length 28 foote, and in bredth with the Chimney 14 foote $\frac{1}{2}$, A Gallery leading to all the sayed Chambers Cont: in length 35 foote, and in bredth with the Chimney 14 foote $\frac{1}{2}$, A Gallery leading to all the sayed Chambers Cont: in Length 35 foote, and in bredth 7 foote $\frac{1}{2}$, A square Turrett ouer the stairecase cont: in Length 12 foote $\frac{1}{2}$ and in bredth 9 foote $\frac{1}{2}$, A Chamber in the Third Story ouer daniell Hall Cont: in Length 27 foote, and in bredth with the Chimney 14 foote.
