One other Garrett Chamber adioyning Conteyning in Length 15 foote $\frac{1}{2}$, and in bredth with the staires 9 foote $\frac{1}{2}$, A litle Seller vnder the Chamber at the end all the yard Cont: in Length 8 foote $\frac{1}{2}$ & in bredth 5 foote $\frac{1}{2}$ One other Seller adioyning onely the passage betweene Cont: in Length 10 foote and in bredth 6 foote $\frac{1}{2}$, Also a Seller next the streate conteyning in length 15 foote, and in bredth 14 foote.

Mr. Osburne Two Tenements sometymes but one

A Chamber next the streate cont: in Length 15 foote, and in bredth with the Chimney 8 foote $\frac{1}{2}$ Another Chamber ouer the kitchen Conteyning in Length and in bredth 8 foote $\frac{1}{2}$,

The Third Story

A Garrett next the streate conteyning in Length 13 foote $\frac{1}{2}$, and in bredth 8 foote $\frac{1}{2}$

The Second Story of thother of the Two Tenements aforesayed being now in the tenure of Nich: Stevens

A Chamber next the streate Conteyning in length 15 foote $\frac{1}{2}$, and in bredth with the Chimney 9 foote $\frac{1}{2}$, One other chamber adjoyning cont: in length and bredth 8 foote $\frac{1}{2}$, Also a garrett next the streate in the Third Story

Mr. Hicke a Tenement in the Tenure of John Sell

The Second Story

A Chamber or Hall next the streate conteyning in Length with the Chimney 19 foote, and in bredth with the entry 16 foote

A little Buttry behinde the same Cont: in Length with the staires 12 foote, and in bredth 7 foote $\frac{1}{4}$,

The Third Story

A Chamber next the streate cont: in Length 20 foote $\frac{1}{2}$, and in bredth with the Chimney 9 foote $\frac{1}{2}$

One other Chamber adioyning conteyning in length 20 foote $\frac{1}{2}$, and in bredth 10 foote $\frac{1}{2}$ with the Chimney

Also a Garrett ouer all in the fift Story with a Chimney in it

A Seller vnder the same howse cont: in length 79 foote $\frac{1}{2}$ and in bredth 10 foote

Mr. Heathersall Two Tenements sometymes but one

The Second Story of one of the sayed Two Tenements aforesayed being now in the Tenure of Henry Joyner from Mr. Hethersall,

A Chamber next the streate conteyning in length 22 foote $\frac{1}{4}$, and in bredth with the Chimney 16 foote $\frac{1}{2}$

The Third Story

A Chamber with a Chimney being devided into The Chamber cont: in Length 24 foote $\frac{1}{2}$, and in bredth 16 foote $\frac{1}{2}$

The ffowrth Story

Two Garretts ouer all cont: in Length 26 foote, and in bredth with the Chimney 16 foote $\frac{1}{2}$

A Seller vnder the same howse conteyning in Length and bredth 15 foote $\frac{1}{2}$

The Second Story of thother of the Two Tenements aforesaid being in the tenure of Philip Hole.

A Chamber ouer the kitchen & Buttry cont: in length with the Chimney 18 foote, and in bredth 10 foote $\frac{1}{2}$, Also a litle roome adioyning to the staires

The Third Story

A Chamber ouer the Chamber aforesayed cont: in Length with the Chimney 18 foote, and in bredth 11 foote $\frac{1}{2}$

The ffowrth Story

A Garrett ouer the same Chamber of the Like bignes

A Seller vnder the same building

The Ladie Ashley a Tenement
